- 1. Meeting called to order by Chairman Gautreau at 5:45 PM.

- 3. Previous Meeting Minutes: Motion by Daigle, seconded by Stewart to accept the previous minutes of December 3, 2024, as written. Motion passed.

- 5. Finance:
 - a. Public Hearing Resolution: Motion by Stewart, seconded by Palmer to accept the findings of the public hearing on January 8, 2025, to increase the previously approved 2025 budget from 21% to 28.2% as the cost of sludge disposal increased by \$143,000 for FY2025. Supt. Arsenault recommended the increase with the understanding that adjustments in the future fiscal years will require additional public hearings. Motion passed unanimously.
 - b. Assistant Supt. banking resolutions addition: Motion by Palmer, seconded by Robinson to add the Assistant Supt. To the banking resolutions. Motion passed unanimously.
 - c. Septage: Received \$6,195.00 in December. Year to date: \$195,133.00.
 - d. Operating Budget: We came in under budget for the year. A remote camera was purchased and will come out of the 2024 budget.
 - e. Draft Financial Statements 2022-2023: Everything was good with a few suggestions on record keeping.
 - f. Single Audit Draft: Supt. Arsenault will schedule a meeting with the auditor for next week to review the audits with the Trustees.
 - g. Issue the 2025 Budget: FML Act Motion by Palmer, seconded by Daigle to have the District pay 100% of the FML in 2025 with the understanding that it will get revisited before the 2026 budget process starts. Motion passed unanimously.
 - h. Capital Project Update: A pre-bid meeting was held at the Plant on December 9, 2024 at 10 AM with the engineers and contractors.
